AN ORDINANCE TO ADOPT BY REFERENCE THE UNIFORM TRAFFIC CODE FOR MICHIGAN CITIES, TOWNSHIPS AND VILLAGES.

THE VILLAGE OF MARTIN ORDAINS:

#### SECTION 1. CODE ADOPTED:

The Uniform Traffic Code for cities, townships and villages promulgated by the Commissioner of State Police on February 14, 1958, and published in Supplement No. 13, and on February 14, 1961, published in Supplement No. 25 to the 1954 Michigan Administrative Code in accordance with Public Act 62 of 1956, State of Michigan, is hereby adopted by reference.

## SECTION 2. REFERENCES IN CODE:

References in the Uniform Traffic Code for Michigan Cities, Townships and Villages to "governmental unit" shall mean the Village of Martin.

## SECTION 3. NOTICE TO BE PUBLISHED:

The Village Clerk shall publish this ordinance in full within one week after passage and shall at the same time publish a supplementary notice setting forth the purpose of the said Uniform Traffic Code and of the fact that complete copies of the Code are available at the office of the Clerk for inspection by and distribution to the public at all reasonable hours.

# SECTION 4. CONFLICTING ORDINANCES REPEALED:

All other ordinances, or parts thereof, inconsistent with the provisions of the Uniform traffic Code are, to the extent of such inconsistency, hereby repealed.

## SECTION A. WHEN EFFECTIVE:

The Uniform Traffic Code will be in effect in the Village of Martin twenty (20) days after the passage of this adopting ordinance.
