ORDINANCE NO. 30 of 1978

AN ORDINANCE TO DESIGNATE CERTAIN STREETS AS THROUGH STREETS WITHIN THE VILLAGE OF MARTIN, MICHIGAN, AND TO PROVIDE PENALTIES FOR VIOLATION THEREOF.

The Village of Martin Ordains:

- Section 1. Main Street, within the Village of Martin, at the intersection of Main Street and Lee Street, is hereby designated as a through street, and traffic on Lee Street shall stop before entering said through street.
- Section 2. Lee Street, within the Village of Martin, at the intersection of Lee Street and Alley running between Lee and East Allegan Street; is hereby designated as a through street, and traffic on the Alley shall stop before entering said through street.
- Section 3. East Allegan Street, within the Village of Martin, at the intersection of East Allegan Street and the Alley running between Lee and East Allegan Street, is hereby designated as a through street, and traffic on the Alley shall stop before entering said through street.
- Section 4. East Allegan Street, within the Village of Martin, at the intersection of East Allegan Street and University Street, is hereby designates as a through street, and traffic on University Street shall stop before entering said through street.
- Section 5. East Allegan Street, within the Village of Martin, at the intersection of East Allegan Street and Chalmers Street, is hereby designated as a through street, and traffic on Chalmers Street shall stop before entering said through street.
- Section 6. Main Street, within the Village of Martin, at the intersection of Main Street and Templeton Street, is hereby designated as a through street, and traffic on Templeton Street shall stop before entering said through street.
- Section 7. Lee Street, within the Village of Martin, at the intersection of Lee Street and University Street, is hereby designated as a through street, and traffic on University Street shall stop before entering said through street.
- Section 8. Chalmers Street, within the Village of Martin, at the intersection of Chalmers Street and Edwards Street, is hereby designated as a through street, and traffic on Edwards Street shall stop before entering said through street.

Section 9. The Traffic Engineer shall place and maintain a stop sign on each street intersecting such through street or intersecting that portion thereof described and designated as such by this ordinace.

Section 10. Any violation of any provision of this ordinance shall be prosecuted under the appropriate section of the Uniform Traffic Code, heretofore adopted by the Village of Martin.

Section 11. This Ordinance shall be effective on the 1st day of July, 1978.
