Amendments to sections 1.003, 1.016a, 1.024, 1.025a-b, 2.5a, 2.6, 2.7, 2.36b, 2.46, 2.52, 2.58, 5.15, 5.16a, 5.35, 5.44, 5.51, 5.69, 5.79a-b-c, 5.86, 5.97, 6.8, 6.16, 6.17, 6.18, 6.23 and 7.4, of the Uniform Traffic Code for Cities, Townships and Villages, and the Amendment of such Uniform Traffic Code by the addition of sections 1.003a-b, 1.016a-b, 1.031b-c-d, 1.043b, 3.12, 4.4a, 4.16, 4.17, 4.18, 4.19, 4.20, 4.21, 4.22, 5.9a, 5.15a-b-c-d, 5.16b, 5.28a, 5.73a, 5.80a, 5.98a, 6.17a, 6.23a, 8.23a-b and 10.1 thru 10.75, or all amendments and additions to said Uniform Traffic Code, all of which were promulgated by the Director of the Department of State Police, effective February 26, 1968 and published in Supplement No. 54 to the 1954 Michigan Administrative Code, in accordance with Act No. 62 of the Michigan Public Acts of 1956, are hereby adopted by reference amending and adding similarly numbered sections of Ordinance Number 7 of 1963 adopted on January 22.

This ordinance will be in full force and effect twenty days from and after its passage, approval and publication, according to the law of the State of Michigan.
